LIST OF SOIL PROFESSIONALS 2024 SOIL EVALUATION INFORMATION

Before a site visit by the soil professional and sanitarian occurs, the following must be accomplished by the requester (owner) of the proposed site:

1. Post a sign at the location, near the road, with owner's name clearly visible from the road.
2. Site is to be properly brush hogged and/or cleared of brush and debris so as to permit proper site evaluation of the total area by the sanitarian at time of site visitation. Care must be taken so that compaction of the soil, which inhibits water dispersion, does not occur. IT IS YOUR RESPONSIBILITY AS OWNER OF THE PARCEL TO SEE TO IT THAT THE GENERAL CONTRACTOR, WELL DRILLER AND ALL PARTIES STAY OFF THE PROPOSED SITE OF THE SEPTIC SYSTEM. BEFORE LAND CLEARING AND EXCAVATION BEGIN, CONSULT WITH YOUR INSTALLER. SOIL DISTURBANCE AT THE SITE COULD RESULT IN RE-EVALUATION OF THE SITE BY A SOIL PROFESSIONAL, REVOCATION OF PERMIT AND POSSIBLE LEGAL ACTIONS INSTITUTED BY THE BOARD OF HEALTH.
3. Stake and label the property boundaries and driveway. (Stake every 50 feet.)
4. Stake and label house/buildings (4 corners for each), sewage system and well (1 stake each).

The following is a list of known, qualified soil professionals who do work in this county. A soil study must be made by a soil professional BEFORE a site evaluation can be conducted by the Health Department. It is the property owner's responsibility to contact the soil professional for this purpose.

Only the original soil evaluation will be accepted – not a copy. The soil evaluation must contain information on several soil borings for the property (one page per boring) and a map.
